Process and Schedule

We are inviting artists/companies (hereafter known as the company) to submit and expression of interest in the form of a presentation. This should include an outline of who you are and your idea and vision for your proposal. It should clearly demonstrate the company's artistic goals and experience and a detailed look at the project and how it meets the aims of the commission. It should also include a delivery timetable and a breakdown of costings.

Budget

A budget of £20,000 is available for the commission. This is inclusive of:

- Artist fees
- Artist travel and accommodation costs and related expenses
- Production costs including materials

Call for submissions to the commission brief: 03rd March 2022 Presentations and Commissions awarded: w/c 28th March 2022 Delivery of project: City of Lights Festival October 2022

Selection process

Applications will be assessed on

- The quality and vision of your idea for the project.
- How it will respond to the City of Carlisle and the Aims of the commission.
- Achievability of the project as outlined according to the budget.
- Achievability of the project given company skills and experience.
- A realistic timescale for creation and subsequent presentation of the work.
